This expenditure for IIC program of MIC will be met from AICTEs' own funds (IRG). Dr. Abhay Jere, CIO of MIC, presented the progress of IIC-1.0 to the Executive Committee. The members of EC appreciated the good work done by MIC under the guidance of Dr. Abhay Jere.

The scheme will be applicable to officers on regular and deputation basis in AICTE. The grants for this scheme will be met from AICTE's own funds (IRG). The observation of IFD, MHRD vide their letter dated 18th June, 2019, on this point may be sent accordingly.

The assignment is temporary and will be for a maximum period of 2 years at a consolidated monthly remuneration of Rs.2.00 Lakhs only".

iii. The Supporting Staff of two (2) to three (3) IT professionals, be engaged as per TAC recommendations in the agenda.
