The EC was informed that Memorandum of Association (MoA) of the proposed IRS is being jointly drafted by AICTE and NBA in consultation with MHRD. Thereafter the same will be placed before the EC for its approval.

The Executive Committee was informed that AICTE received a request from the office of HRM for deputing one qualified Consultant who can help in popularizing the initiatives of MHRD and AICTE among students, teachers and institutions. The Executive Committee considered and approved the recommendations of a Committee to the proposal for engagement of a Consultant (MHRD Initiatives) in AICTE on outsourced basis through M/s. BECIL as per educational qualifications, remuneration, age, functions etc.

Item No. 127.03.10

To consider and decide the action to be taken by the AICTE in respect of applications, if any, to be received in the AY 2020-21 for starting additional Pharmacy Courses in existing Institutions.

The Executive Committee deliberated on the proposal and noted that the Pharmacy Council of India (PCI) has passed the resolution to put a moratorium on the opening of new Pharmacy Colleges for running Diploma as well as Degree course in Pharmacy for a period of five years beginning from the academic year 2020-21. This moratorium shall not be applicable in the North Eastern Region of the Country where there is a shortage of Pharmacy Colleges.

The EC also noted that AICTE's Board of Studies for Pharmaceutical Education (AIB-PE) has also given its opinion not to start any new Pharmacy colleges for the next two years. The EC

therefore resolved that that since AICTE's and PCI's respective decision to put a moratorium on opening of new Pharmacy colleges coincides for at least a period of two years, the Executive Committee approved the recommendation that no new Diploma/Degree / PG level institutions be approved for the next two years except:

- a. those in the North Eastern Region; and
- b. the proposals which are in pipeline and institutes who have applied in previous years but LOI / LOA was not granted.

Subsequently after two years, AICTE may take a fresh call on continuation of moratorium or otherwise in respect of Pharmacy colleges in consultation with PCI.

The EC also approved the recommendations of AIB-PE on Curriculum of Degree Pharmacy and its other recommendations as per its minutes of the meeting held on  $8^{th}$  July, 2019.

To consider the proposal for processing of applications for change of Name of Trust/Society/ Change of Site, beyond 30<sup>th</sup> April, throughout the Academic Year.

The Executive Committee deliberated on the proposal and approved processing of applications for change of name of Trust/Society/ Change of site, beyond 30th April, throughout the Academic Year. The EC also decided that such applications which are lying pending as on April 30 could be processed as and when applicant could obtain requisite NOCs on or before the announcement of the next approval process, since change in name of Trust/Society/Change of site has no direct linkage with grant of approvals to an institute and does not affect the intake capacity. The EC opined that an appropriate clause may be included in the next Approval Process Handbook (APH 2020-21).

The Executive Committee deliberated on the matter and decided that more concrete efforts may be taken to get the prize money from the defaulter organizations i.e. NCORD and Skippersell. The EC also suggested that suitable amendments may be made in criterion of SIH and for other similar activities, such that participating organizations may deposit prize money etc. before the scheduled event. To consider and approve the minutes of the meeting of Committee for disposal of obsolete/ unserviceable equipment/furniture held on 29.05.2019 at AICTE-SWRO, Bengaluru.

The Executive Committee was informed that the unserviceable equipment/furniture at SWRO-AICTE, Bengaluru were procured by ISTE / AICTE. The EC opined that original cost of such equipment is required to calculate depreciation which is missing in this case, therefore, ISTE may be approached to ascertain cost and based on that depreciated cost be decided. However, the Committee was informed that this was already asked for, but since its very old case these papers are not traceable in ISTE. The Executive Committee therefore decided to write off these items.

To consider and approve funds from AICTE non-planned for MIC Activities.

The Executive Committee considered and approved the proposed additional amount of Rs.1.68 crore from AICTE funds for the routine expenses and already planned activities during the F.Y. 2019-20 of MHRD's Innovation Cell (MIC). The EC was informed that this amount is a stop gap arrangement for the salaries of MIC staff and already planned MIC activities, however, MIC will prepare a revised budget proposal for 2019-20 for the approval of the Executive Committee.

To consider and approve the budget proposal for conducting 200 training programmes by four AICTE Training And Learning (ATAL) Academies during the year 2019-20.

The Executive Committee noted that in its 125<sup>th</sup> meeting held on April 26, 2019 had approved for conduct of 50 training programs in thrust areas in a year by each ATAL academy on a budget of Rs.1,62.500/- per training program. As such, the proposal for 200 training programmes under four ATAL academies are planned, under which few have already started. Accordingly, the Executive Committee approved budgeted amount of Rs.3,25,00,000/-(Rs.1,62,500 per programme x 200 programmes) to be earmarked for the F.Y. 2019-20 in four ATAL academies.
