Under Item No. 127.03.19 the EC was informed that after reappropriation of outsourced manpower, the unfilled strength of 12 nos. indicated earlier are now filled-up as per the needs of different bureaus/cells of AICTE. Hence, as on date, there is no vacant position. The EC opined that a separate Agenda item for next EC meeting be prepared for its approval regarding working at AICTE hqs. and its Regional/Camp offices.

Item No. 129.03.02

To approve the proposal for conducting 500 training programmes by ATAL academies in the year 2020-21.

The Executive Committee noted that in its 125th meeting held on April 26, 2019 had approved the proposal of ATAL for conducting twenty training programmes with an estimated budget of Rs.32,40,000/- in the twenty ATAL academies @ Rs.1,62,000/- as cost for one workshop. The EC also noted that in its 127th meeting held on August 21, 2019, approval was granted for conduct of 200 training programs in FY 2019-20, with a budget of Rs.3,25,00,000/- (Rs.1,62,500/- per workshop) for four ATAL academies.

The EC was informed that during 2020-21 more number of such programs are to be conducted by all Regional Offices of AICTE and hence the revised budget estimates have been presented in the proposal.

The EC considered the proposal and approved conduct of 500 training programmes by ATAL academies from the next Financial Year i.e. 2020-21 in the nine thrust areas viz. AI, Block Chain, IOT, etc. and other emerging /training areas.

The EC also approved that the government funded institutions like IITs, IIMs, NITs, IIITs, Central Universities, States Universities, other government organizations, private organization/institutions having NIRF ranking up to 100 / NAAC grade "A" and Departments of Universities /Institutions which are NBA accredited & having validity upto March, 2020 may also be funded for conduct of ATAL Programmes.

The EC further approved that all Regional and Camp offices may conduct ATAL academies programmes in their region/states under their respective jurisdiction.

The EC considered and approved the revised budget estimate from Rs.1,62,000/- (FY (2019-20) to Rs.2,10,000/- (FY 2020-21) for

The revised estimates consist mainly travel expenditure of Experts from other cities, which was not included in earlier approval. The provision of providing one book each costing about Rs.500/- to the best performing teachers in training program, which is limited to 20 numbers.

The EC was also informed that apart from nine emerging viz. Artificial Intelligence, Internet of Things (IoT), Block chain, Robotics, Quantum Computing, Data Sciences, Cyber Security, 3D Printing & Design, Augmented Reality (AR)/ Virtual Reality (VR), new areas according to demands of industry may emerge which will require good experts to prepare syllabi & documentation and shall incur fee. Also, it was informed to have impact assessment, i.e. measuring the effectiveness of ATAL Academy programs and judging the significance of changes brought about by those activities in faculty development. The Impact Assessment will also require to incur expenditure. The EC, thus, approved additional budget of Rs.0.50 crore for the projected expenditure for the proposed 500 programs in FY 2020-21.

The Executive Committee therefore approved a total budget of Rs.11.00 crores (500 programmes x @ 2.1 lac per programme = 10.5 crores + 0.50 crore for related activates -Impact assessment, syllabi/ documentation of new areas) during the year 2020-21.

To consider and approve allocation of additional budget for running ongoing programs of MHRD's Innovation Cell (MIC) till F.Y. 2019-20.

The Executive Committee deliberated on the proposal of allocation of budget for the ongoing programs of MIC. The EC was informed about the successful progress being made under various activities of MIC and necessity of funds to continue the effective implementation in achieving targets of 2019-20. Accordingly, the Executive Committee approved the proposal of allocation of additional budget of Rs.13.70 crore for various ongoing activities of MIC till FY 2019-20. The EC further directed that this additional budget of Rs.13.70 crore of MIC will be met from the Internal Revenue Generated (IRG) of AICTE. The Executive Committee had endorsed the decision of MHRD and decided that IRG of AICTE may be utilized for funding the projects of MIC. Further, the Secretary (HE), MHRD vide his email dated November 20, 2019 has clarified that though 'the DoE hasn't agreed with MIC funding, it shall have no effect whatsoever on AICTE expending its own resources'. Accordingly, the decision of EC is in consonance with the MHRD clarification.

Item No. 129.03.08

To consider and approve enhancement of Ph.D. Fellowship under the scheme of National Doctoral Fellowship (NDF) scheme.

The Executive Committee deliberated on the proposal and approved enhancement of the fellowship in consonance with MHRD's letter F. No. 15-2/2019-TC dated 16th July 2019, for NDF scholars w.e.f. 01.01.2019, as under:

- JRF: Rs. 31,000/- per month for 1st & 2nd year.
- SRF: Rs. 35,000/- per month for 3<sup>rd</sup> year and onwards in case of extension as per the provisions of the scheme.

All other emoluments and guidelines are applicable as per the GOI OM dated 31-01-2019.

To consider and approve providing conveyance facility to woman employee at work place.

The Executive Committee deliberated and decided that conveyance/TA rules applicable to woman employees beyond office working hours shall be as already prevailing in AICTE and DOPT, GOI norms.

Item No. 129.03.10

To consider and approve the methodology for assessment and recommendation on the proposals of the Higher Educational Institutions (HEIs) for offering MBA, MCA and other programmes through ODL and Online mode being received by UGC, New Delhi.

The Executive Committee deliberated at length on the matter raised by UGC vide their letter dated 25-09-2019 and decided as follows:

# 1. For offering Courses through online mode:

The Executive Committee reiterated as discussed and decided in its 125<sup>th</sup> meeting held on April 26, 2019 on the online mode of courses as follows:

a) The Eligibility Criteria for admission and process of admission should be on the lines of ODL courses;

 b) Availability of good quality course content/ regular updation of course content for a rich learning experience of the candidates enrolled;

 c) Availability of reputed Experts of respective disciplines for online interaction or through Skype or any other digital medium, for clarifications/ clearing of doubts of candidates enrolled in online course;

 d) Arrangement of regular assignment to enrolled candidates and their online evaluation/feedback;

 e) The Examination system should be proctored to ensure fairness and transparency.

The Executive Committee deliberated on the point b) above and further clarified that all the Universities that intend to offer online/ODL courses are conducting the same courses in regular mode also. So, it is expected and presumed that contents of these regular courses are of good quality and are being updated periodically. The same course content should be used for online and ODL courses. However, such Universities may be asked to submit an affidavit to UGC that they are adhering to all the above conditions.

# 2. For offering courses through ODL mode:

The Executive Committee reiterated as discussed and decided in its 118th meeting held on August 18, 2018 on the ODL mode of courses as follows:

a) All the Deemed-to-be-Universities notified by UGC as Category-I institutions as per UGC (Categorization of

Am.

universities (only) for grant of graded Autonomy) Regulations, 2018 shall be exempted from seeking approval from AICTE for the programmes mentioned in Sl. No. 1 above i.e. MBA, MCA, Diploma/Degree in Travel and Tourism. However, such Deemed-to-be-Universities shall have to adhere to norms & standards announced by AICTE from time to time and an affidavit stating that the deemed-to-be university is observing norms & standards of AICTE, must be submitted to the UGC. For all such UGC notified Category-I Deemed-to-be-Universities, the AICTE approval shall be considered as deemed to have been accorded for running ODL programmes in MBA, MCA, Diploma/Degree in Travel and Tourism. However, in case of violation of AICTE norms reported through complaints, AICTE shall conduct inspection and submit its observations and recommendations to the University Grants Commission (UGC) to initiate actions including withdrawal of Programme recognition and take further actions as per provisions of UGC (ODL) Regulations.

b) For all other Deemed-to-be-Universities other than Category-I Deemed-to-be-universities as mentioned at point (2) above, interested in running ODL programs in MBA, MCA and Travel & Tourism, AICTE shall invite applications and such Deemed-to-be-Universities shall submit applications online on the AICTE web portal within notified deadline and shall be processed as per Notification issued in this regard. AICTE will forward the recommendations to UGC for further necessary action in the matter.

However, the Hon'ble High Court of Delhi in its decision under WP(C) No. 261/2019 dated 19-07-2019 under Dayalbagh Educational Inst. Vs. UGC and Others, directed AICTE to frame Regulations for granting approval to Deemed-to-be-Universities offering courses in ODL mode. The EC was informed that AICTE has accordingly framed regulations for Deemed-to-be-Universities and will give approvals to Deemed-to-be-Universities offering to conduct ODL courses as per laid down norms in the regulations.

The Executive Committee also noted that as per UGC regulations on ODL mode for the course of MBA, MCA and Travel & Tourism, for other Private and State Universities, approval of the regulatory body is required. Accordingly, the EC decided that all such cases will be dealt with the same regulations of AICTE as notified for Deemed-to-be-Universities and in such cases the recommendations of AICTE will be communicated to UGC for taking further necessary action at their end.

In general the Executive Committee reiterated that any course to be offered in regular or ODL or online mode should ensure:

a) Prior approval of AICTE;

- Sanctity of admissions as per chosen policy declared in advance;
- Good quality Learning material and interaction with faculty;

d) Standard of examination papers;

- e) Sanctity of examination: Proctored examination;
- f) Timely evaluation of exam papers and announcement of results.

### 3. Permissible Specializations:

AICTE is not granting approvals to Universities and Institutions to offer Diploma/UG/PG level courses in Engineering & Technology, Pharmacy, Architecture, HMCT, Applied Arts Crafts and Design through ODL/Online mode. Course nomenclature like Post Graduate Diploma in Artificial intelligence/Block Chain/Information Technology etc. shall arouse confusion amongst its aspirants and stake holders that whether the same are falling under the ambit of AICTE/Technical education. The EC is of the opinion that UGC shall not permit such nomenclatures of courses to be offered in ODL/Online mode. Further, the Programs like B.Sc. and M.Sc. do not fall under the ambit of AICTE, so the Executive Committee did not consider this matter.

### 4. Conduct of Examinations:

The Universities / Institutions Deemed-to-be-Universities offering such courses in online or ODL mode shall ensure that the Examinations are conducted in a proctored manner.

### 5. Award of Degree:

The Executive Committee opined that universities offering courses through ODL/Online mode shall clearly mention in the Degree Certificate issued to the candidates that the course was offered in ODL/online mode as the case may be.

## 6. Registration with NAD:

All the Universities offering such courses must register with NAD and upload the data of the students on NAD portal.

To consider and approve proposal for closure of M.Tech./M.Pharm Programme under QIP Scheme of AICTE for Major and Minor QIP Degree Engg. /Pharm Centers.

The Executive Committee was informed that the M. Tech. is not the basic minimum qualification requirement for diploma level

teachers, however, the same is the minimum entry level qualification for degree level colleges. The EC deliberated on the proposal and approved the closure of M.Tech./M.Pharm Programme under QIP for faculty of degree colleges at Major and Minor QIP Centers of AICTE, however, M.Tech. Program under QIP (Poly) will continue for the faculty of Polytechnic colleges.

Item No. 129.03.12

To consider and approve the proposal for change of funding for some of the schemes from Non-plan budget Head to Plan-Budget Head.

The Executive Committee discussed and approved the proposal of shifting the following schemes from Non-Plan head to Plan head of the budget:

- a) FDP-Faculty Development Programme;
- b) Short Term Training Programme (STTP)/AICTE-ISTE Induction / Refresher Courses and others;
- c) GOC- Grant for Organizing Conference;
- d) MODROB (Modernization and Removal of Obsolescence), all types of MODROBS.

To consider and approve the proposal for composition of Technical Teachers Policy Training Monitoring Committee and Cell.

The Executive Committee deliberated on the proposal and approved constitution of the Technical Teachers Training Policy Monitoring Committee and cell in RIFD Bureau of AICTE as under:

**Policy Monitoring Committee:** 

- a) Prof. HP Khincha and Prof. RP Dahiya (Committee members for finalization of the Comprehensive Training Policy for Technical Teachers).
- b) All four Directors of NITTTRs.
- c) Two VCs from Technical Universities (on rotation for period of 02 years) To be nominated by the Chairman, AICTE.
- d) An IT expert To be nominated by the Chairman, AICTE.
- e) Advisor-I, RIFD Bureau, AICTE.
- f) Director, RIFD Bureau, AICTE Member Secretary.

Mandate and charter of the committee would encompass the following: -

- Coordination, nomination with NITTTRs on development of modules for all phases of in service teachers. Also ensuring capacity building of Inter NITTTRs & its methodology;
- ii) Ensuring development, implementation and continuous monitoring of the registration portal as per the scheme document:
- iii) Ensuring close coordination with the State Technical Departments, Technical Universities, Atal academies and other nominated institutes for building awareness, support system and implementation of Technical Teachers Training Policy;

The Executive Committee noted that 120 proposals with a maximum budget of Rs.20.00 Crores was approved in its 120<sup>th</sup> meeting held on 27-12-2018. Rs.15.00 Crores are required for releasing grant to 120 proposals out of the recommended 186 proposals under MODROB Rural Scheme 2019-20. The EC was informed that for releasing grant to all 186 (120+66) recommended proposals, total budget required is Rs.24.00 crores, i.e. additional Rs.4.00 crore is required against its approval in 120<sup>th</sup> meeting.

The Executive Committee considered and approved the remaining 66 qualified proposals out of 186 proposals recommended by experts/evaluators under MODROB-Rural Scheme. The EC also approved an additional amount of Rs.4.00 crore to meet the expenditure for release of Grant-in-Aid to all 186 recommended proposals under MODROB Rural Scheme 2019-20.
