At the outset, Prof. A.D. Sahasrabudhe, Chairman, AICTE welcomed all the members to the 133rd emergent meeting of the Executive Committee. He informed the members about the urgent nature of agenda items being placed in today's meeting, amidst closure of institutes and transport in the country due to COVID-2019 pandemic. Maintaining the norms of physical distancing in this crisis period, the members joined this meeting through Video Conferencing. The Chairman, briefed the members about the recent activities / achievements of AICTE since last reported in the 132nd meeting of the Executive Committee held on 23-03-2020. He shared the same with the members joined online through Video conferencing in the form of ppt presentation (Annexed) which included launch of Student Helpline portal, launch of ELIS portal, access to free portal on e-learning resources for students, USVA-2020 with the theme: India Fights Corona. In addition to this, the online UHV workshops on SIP, Internships and proposed MoUs with NHAI & MoHUA, Impact Workshops, other work from Home Internships. NITTT, Margdarshak, Online FDPs under ATAL, NEAT, Examination Reforms, Mapping of SWAYAM courses to AICTE for the model curriculum of UG courses in engineering. Further, EC was apprised about development of portal for latest updates, ongoing activities and initiatives of AICTE, portal developed to facilitate uploading of research work in Indian Knowledge Systems, Instructions issued to institutions vide letter dated 15-04-2020 during lock down period, release of PMSSS and various other scholarships, upcoming launch of Anandibai Award for empowering women and innovation activities: Fight Coronoa IDEAthon/ SAMADHAN / Leadership talks. AICTE has tried to ensure that these online activities have far reaching positive impact on Students, Faculty/ Institutions during the lockdown period. The EC members applauded the efforts made by AICTE during tough time of COVID-2019 under the dynamic leadership of Prof Anil Sahasrabudhe, Chairman AICTE.

Chairman on behalf of AICTE congratulated and acknowledged the contribution of the Frontline Corona warriors to fight against COVID-2019 and all AICTE employees.

The following Agenda Items were taken up for consideration, deliberations and decisions taken are as under:

Item No. 133.01

: To consider the proposal of modifying the procedures specified in APH 2020-21 to ease the process of approval due to spread of Coronavirus (COVID -19), lock down throughout the nation.

The Executive Committee was informed that due to the spread of Coronavirus (COVID-19), lock down throughout the nation, the completion of the Approval process requires modification in its procedure and calendar stipulated in APH 2020-21. It is also apprehended that even after the lifting of lockdown, expecting normalcy will be slightly doubtful. organizing Scrutiny Committee by calling the representatives or sending a team of EVC experts to various places would be highly unsafe as well as commuting will also be difficult. The EC was apprised that online meeting platforms for conducting Scrutiny/ EVC with local available experts may also be attempted for granting approvals to the Institutions, with the existing Sitting Fee for experts. Dr. Usha Natesan, Adviser, Approval Bureau briefed the members on the proposed modified procedure in APH 2020-21, through Video Conferencing

The EC approved the above modified process of approval for all similar courses under the ambit of AICTE and spelt in APH 2020-21. Further, in case of difficulty in getting stamp paper or the attestation by the Authorities at this time, the EC suggested to accept the Signed Undertaking on the Letterhead of the Institutions, but the Institutions shall submit the Affidavit on a Non-Judicial Stamp Paper on or before 30th June 2020.

The Institutions applied for EoA without any changes vis-à-vis last year's approval, based on the self-disclosure have been approved by the Executive Committee and such Institutions may download the EoA letter from the AICTE web portal from 30th April 2020.

The Executive Committee further considering the exigency and extraordinary situation, approved the action taken to appeal the Hon'ble Supreme Court of India to extend the date for grant of approval upto 15<sup>th</sup> June 2020 as per the following modified Academic Calendar (Appendix 19 of APH).

The Academic Calendar shall be in line with the UGC guidelines with minor changes as above especially in respect of standalone PGDM/PGCM institutes.

It was also decided that classes shall start as per above calendar. However, physical classes may only start after the MHRD, GoI decides on this aspect. But online classes may start as per above calendar.

The Executive Committee noted and approved that during this online process of approval, new / more local available Experts may be identified from various disciplines to be utilized for Scrutiny Committees and EVCs which may be carried out by all regional offices.

The EC opined that provision shall be made in the Portal for the experts of the Scrutiny Committee/ EVC to view all the documents uploaded by the Institutions at least one day prior to the date of the online meeting.

Item No. 133.02

: To consider and approve the request of the Chief Secretary, Govt. of Telangana, for the grant of EOA for 238 institutions in South Central Region in A/Y 2020-21.

The EC deliberated and also noted that the MHRD is aware of the entire issue which needs to be resolved at the earliest. The EC, therefore decided to keep the matter on hold till the response of MHRD is received and same may be placed before the next meeting of EC for a final decision.

Item No. 133.03

To consider and approve functioning of Innovation Cell under administrative and financial control of AICTE.

The Executive Committee noted that the Innovation Cell of MHRD was established with the approval of Ministry of HRD, GoI vide their letter No. 36-20/2018-NVEQF dated 30<sup>th</sup> May 2018 for setting up of Innovation Cell be operated in AICTE with its own resources. The MHRD had also approved annual budget with restricted outlay of Rs.6 Crore per year for a period of 2 years i.e. 2018-19 to 2019-20.

The EC also noted that:

- i) The posts of Chief Innovation Officer, Innovation Director, Assistant Innovation Director and Innovation Officers of MIC were approved on contract basis for a period of 2 years;
- ii) MHRD now vide its letter dated 20-03-2020 has accorded extension of MIC for three more years from 1/04/2020 to 31/03/2023 and has also informed that the Integrated Finance Division of MHRD has remarked that as AICTE is the regulator for the Technical Education in the country, it may run the Innovation Cell or any other similar Cell, if deemed necessary as per its mandate. Also, the activities of MIC do not overlap with ATAL Innovation Mission (AIM) of NITI Aayog.
- iii) MHRD has agreed that MIC may function under AICTE with the above mentioned posts and AICTE may provide necessary support staff to MIC.

The Executive Committee in consonance with MHRD's letter dated 20.03.2020, has decided that MIC will continue to function under the administrative and financial control of Member Secretary, AICTE.

The EC approved the continuation or otherwise of the existing / selected officers of MIC for another three years but after obtaining the satisfactory self appraisal of earlier term through proper channel. The appointment letters be issued after the concurrence of EC and MHRD. The terms and conditions of appointment shall be the same as approved

earlier by the EC.

The EC while noting its decision in its 130<sup>th</sup> meeting and MHRD's aforesaid letter of 20-03-2020, approved the proposal of issuing letters of appointment to Mr. Dipan Sahu for the post of Assistant Innovation Director and Ms. Selva Rani for the post of Innovation Officer.

The Executive Committee also approved the requisite budget of MIC to be carried forward for the FY 2020-21 to meet the day to day requirements. The EC further approved an amount of Rs.6.00 crores per year to be met from IRG of AICTE. The EC opined that MIC should prepare a detailed report about the outcomes of last two years, prepare a holistic plan for the next two years with clearly defined outcomes and detailed budget for the year 2020-21 which shall be in turn shared with MHRD and after consent from MHRD placed in the EC for approval.

All officers and staff of MIC were acknowledged for their contribution in various Innovation activities, Hackathons, Startups etc. and allotment of a dedicated DTH Swayam Prabha Channel for Innovation activities.

Item No. 133.04

To consider and approve conducting online FDP under AICTE Training and Learning (ATAL) Academies and budget for Rs.77,19,000/- for conducting 83 online FDPs during lockdown period in April, May and June 2020.

The Executive Committee was informed that AICTE Training And Learning (ATAL) Academies have started unique faculty development programs in various thrust areas of modern technology. Approximately 200 such programs have already been conducted in various government institutions benefitting around 10,000 faculty, research scholars & PG students. Seeing the success of this initiative, ATAL Academy has announced to organize 500 FDPs across the country for FY 2020-21.

The EC also noted that the proposals were invited for conducting 500 face to face FDPs which were being finalized; however, it got delayed due to countrywide lockdown. During this lockdown period, online FDPs were proposed to be conducted so that faculty may utilize their time fruitfully. Looking at the tremendous response and popularity of these FDPs amongst faculty, total of 83 such online FDPs are announced to be conducted in April, May and June 2020. Few online FDPs have already been conducted and others are in the pipeline.
