At the outset, Prof. A.D. Sahasrabudhe, Chairman, AICTE welcomed all the members to the 147th meeting of the Executive Committee. The Chairman briefed the members about the recent activities/achievements of AICTE since last reported in the 146th Executive Committee meeting held on October 27, 2021, in the form of ppt presentation. The details are enclosed as **Annexure-1**. The Executive Committee members appreciated the efforts made by the team AICTE and its outstanding achievements.

The members were informed about the comments received from IFD, MoE, on the Agenda and accordingly decisions were arrived at while taking these comments into cognizance. The following Agenda Items were taken up for consideration, deliberations and decisions taken as under:

Item No. 147.01.01

To confirm the minutes of the 146th meeting of the Executive Committee held on October 27, 2021.

Item No. 147.02.01

To receive a note on action taken on the decisions and recommendations made in the 146th meeting of the Executive Committee held on October 27, 2021.

The Executive Committee received the action taken on the decisions and recommendations made in the 146th meeting of the Executive Committee held on October 27, 2021.

Under Item No. 146.03.13 in the ATR, the Executive Committee was further of the opinion that more books in various regional languages particularly in Hindi language may be purchased by AICTE from the publisher and made available to_institutions, so that students opting for studying in regional languages get encouraged and empowered.

Item No. 147.03.01 StDC To consider and approve mobility of undergraduate students in India for research in Canada under AICTE-Globalink Research Internships(GRI).

The Executive Committee was informed that AICTE entered an MoU with Mitacs, Canada in the year 2018 to support 300 students for Globalink Research Internship in Canadian University. The expenditure of AICTE-MITACS Globalink Research Internships (GRI) is \$12,000 CAD on each student. It was decided that MITACS will share the cost of \$9000 CAD per student & AICTE will contribute \$3000 CAD per student for 100 students. However, to AICTE's suggestion for charging remaining 200 students \$3000 CAD each out of \$12000 CAD and remaining \$9000 CAD each will be borne by Mitacs, Canada, the MITACS did not accept this.

The EC was further informed that in the year 2019, a total of 64 students had been selected for the Internship program. In the year 2020, the internship program was called off due to COVID pandemic. Further, in the year 2021, due to COVID-19, 358 students attended the virtual internship @ \$ 850 CAD per student amounting to \$304300 CAD.

Now, MITACS has requested AICTE to bear 25% of the total internship amount of \$12000 CAD of 300 students as it is not appropriate to collect the share amount from students.

The EC was also informed that for the AICTE-MITACS Globalink Research Internships Scheme (GRI) 2022, a total of 2144 students have been found eligible out of the 2281 applications received. MITACS has intimated that since a large number of applications have been received, the total number of selected applicants may be higher than 300. MITACS has conveyed its willingness to support full support of internships for additional students beyond 300 and has stated that it would not be appropriate to charge students for internship.

The Executive Committee considered and approved the proposal that for AICTE-MITACS Globalink Research Internships Scheme (GRI) 2022 onwards, AICTE will provide financial support of \$3000 CAD to each of the 300 students selected for the Internship Program, wherein the total expenditure will be \$9,00,000 CAD i.e. which is about Rs. 5,37,03,000.00 (Rs. Five Crore Thirty-seven lakh three thousand only), for making its contribution to MITACS every year. The amount towards the same will be met out of the non-plan funds of AICTE i.e. IRG of AICTE. The Executive Committee also approved the proposed amended scheme guidelines.

The Executive Committee was informed that AICTE is running three variants of "Campus Accommodation & Facilities Enhancing Social Experience (CAFES)" addressing the needs of SC/ST and differently abled students in North Eastern Region.

The Executive Committee noted that a new variant to fund construction of hostel catering to the institutions located in Remote /Aspirational areas/ Island locations and operate it as AICTE-CAFES (RAIL) has been proposed keeping in view the cost index of various cities based on DPAR CPWD for construction work, will be applicable to institutions located in Remote/ difficult areas covering J&K, Ladakh, Andaman & Nicobar Islands, Lakshadweep etc. and approved the following budget:

Item No. 147.03.03 IDC

To consider and approve the proposal to revise the limit of funding under AICTE-CAFES (NER) Scheme.

The Executive Committee was informed that during its 113th meeting held on 06-03-2018, under the CAFES(NER) scheme, the revision in the limit of funding was approved from Rs. 2.00 Crore to Rs. 3.25 Crore for construction of hostel. Further, as per cost index of various states/cities as on 01.04.2021 based on DPAR CPWD for construction work, the expenditure for construction of hostel in states in NER has been calculated and revision of the limit of funding has been proposed. The EC was further informed that MOE vide its letter dated 01-11-2021 has forwarded a letter of the Minister of Tribal Affairs and Higher Education, Govt. of Nagaland, requesting to enhance funds to Rs.4.00 crore for facilitating the state to provide quality infrastructure.

The Executive Committee considered and approved the proposal of revision of financial support for construction of hostel under CAFES-NER scheme retrospectively applicable since the inception of the CAFES-NER scheme w.e.f. 2020-21 as mentioned below:

The Executive Committee noted that vide decision in its 145th meeting held on September 13, 2021, AICTE shared the report of the National Fee Committee (NFC) with the State/UT Secretaries and the State Fee Regulatory Committees in a confidential manner.

The EC was informed that AICTE has received views/comments from 10 States/UTs on the recommendation of the National Fee Committee Report. The EC was further informed that under W.P (C) 5155/2020, the Federation of Self-financing Technical Institutions & ANR vs UOI & ANR relating to fee fixation, Hon'ble High Court, Delhi in its order dated 27.10.2021 directed AICTE to complete the

process of finalizing NFC report within 6 weeks and take a final decision in the matter. In the next hearing held on 29.11.2021, the Hon'ble High Court was apprised about the developments and now the next date of hearing in the matter has been fixed for 01-03-2022.

The Executive Committee deliberated at length on the comments received from different States/UTs on the report of National Fee Committee. The Executive committee thereafter resolved that AICTE may constitute a sub-committee to revisit the recommendations of the report as well as examine the comments received from different States/UTs while specifically looking into on various issues including broader terms of reference:

- To review the comments on National Fee Committee (NFC) report August 2021 received from different States / UTs.
- To revisit the high fees charged in Design" Applied Arts & Crafts programmes.
- To recommend possible changes based on the inputs received from States / UTs.

The Executive Committee decided that a 30 days' time may be given to the aforesaid Sub-committee for submitting its observations and recommendations. The same may be placed before the Executive Committee in its next meeting.

Item No. 147.03.05 MIC

To consider and approve hiring of one UX/UI Designer from the existing manpower agency M/s. BECIL for MoE's Innovation Cell (MIC) at AICTE.

The Executive Committee considered and approved the proposal of hiring of one UX/UI Designer from the existing manpower agency M/s. BECIL for MoE's Innovation Cell (MIC) at AICTE as per the proposed job description and suggested remuneration.

Item No. 147.03.06 MIC To consider and approve the updated funding amount of KAPILA scheme as per gazette notification.

The Executive Committee was informed that the KAPILA scheme was launched by the Ministry of Education's Innovation cell and AICTE with an objective to recognize, facilitate the Intellectual Property, Innovations, and best practices in HEIs. The scheme aims at providing the financial assistance to the institutions that are of the Higher Education Institutions for filing patents. The Executive Committee in its 141st meeting held on 17th March, 2021, approved the KAPILA scheme document and its funding.

The EC was further informed, that recently Govt. of India has issued a gazette notification on 21st September 2021, to reduce the patent-related fees by 80%. Accordingly, the KAPILA scheme document has been updated as per the gazette notification. The eligible entries will receive funding support with an upper limit of ₹5600 (Patent filing fee of ₹1600 and request for Examination fee ₹4000)

The Executive Committee considered and approved the proposal by accepting the updated KAPILA scheme document with updated funds as per the aforesaid gazette notification dated 21st September, 2021. The EC noted and decided that since KAPILA is a reimbursement scheme, the utilization certificate is not required, however, proof of utilization through head of the institution should be obtained.

Item No. 147.03.07 P&AP Bureau

To consider and approve the committee report/ recommendations to decide eligibility for entry to Engineering/Technology program.

The Executive Committee was informed that AICTE has made provisions for flexibility in eligibility criteria for admission to undergraduate Engineering and Technology in line with NEP 2020. The EC was also informed that AICTE had also constituted a committee under the Chairmanship of Prof K.K Aggarwal on 14th May 2019 to examine and recommend subjects to be pursued at 10+2 level with Agriculture/Biology/life Science subject for admission in B.E. / B. Tech Program in Engineering and Technology. Meanwhile, AICTE opened up the window of opportunity by broadening the entry level qualifications. The Executive Committee in one of its meetings, deliberated and decided to provide 14 subjects possible options for admission engineering. However, there were lots of reactions for and against the same which were addressed by the authorities at the AICTE for clarifying the misconceptions regarding the decision taken by the stakeholders.

The EC was further informed that keeping in view the reactions of the stakeholders, AICTE decided to extend the mandate of the Committee with addition of some more members to the group from across the disciplines and from all kinds of Institutions. Accordingly, the committee was expanded by including special invitees. The committee also took the views of various stakeholders from industry and academia, Finally, the committee has submitted its report/recommendation to AICTE after deliberating rigorously and conducting frequent meetings.

Prof. K. K. Aggarwal, Chairman, NBA who was a 'Special invitee', presented the findings and recommendations of the Committee to decide eligibility for entry to Engineering/Technology programs.

The Executive Committee deliberated on the matter and approved the report/recommendations of the Committee regarding eligibility for entry to Engineering/Technology programs. The EC recorded its deep appreciation to the Chairman and members of the Committee for the exhaustive exercise done on deciding the eligibility for entry to Engineering/Technology programs. The EC also suggested for sharing the Committee report and decision of the EC to NITI Ayog.

To consider and approve the funding of Republic day Tableau of Ministry of Education.

The Executive Committee was informed about the proposal of MoE to design a Tableau/Jhanki on National Education Policy (NEP) for the Republic Day Parade 2022. It was also informed that a committee was constituted to help in conceptualising the theme. The committee has come up with a concept sketch/design and also proposed 'Vedas to Metaverse' as the theme of the Tableau, which has been agreed upon by Ministry of Defence (MoD), and certain changes were suggested by MoD which are being incorporated by the committee.

The Executive Committee was informed that another committee was constituted to finalize the budget and the tender documents for inviting quotations/expression of interests from the experienced agencies for designing, fabricating and display of the Tableau as per the guidelines issued by MoD.

The Executive Committee considered the proposal and decided that due to paucity of time, RFP at this stage may not be possible since the design has not been finalized till now. Moreover, Executive Committee also suggested that since this is an aesthetic and quality work, we proactively identify agencies having good experience in Republic Day parade tableau design and fabrication. Preference should be given to government agencies/institution like JJ School of Arts, Mumbai which is an institute of high repute and also has considerable experience in Tableau design. The EC also considered the proposed budget outlay as suggested by the committee of Rs.1.07 crore (inclusive of all taxes) for complete design and fabrication of Tableau to be met from IRG of AICTE.
