All India Council for Technical Education, established under the AICTE Act, (52 of 1987), having its Registered Office at Nelson Mandela Marg, Vasant Kunj, New Delhi-110070, India, (hereinafter referred in short as AICTE)" (which term shall unless expressly excluded by or is repugnant to the context, shall include its successors and assigns) of the SECOND PARTY; together with First Party known as parties.

Definitive Agreement: There will be no financial obligation on the part of AICTE for implementation of this MoU. Any cost associated with the execution of the

scope of this MOU, if any, shall be mutually discussed and agreed to between the parties in a definitive agreement, prior to carrying out the activity.

Term and Termination: The term of this MoU shall be for a period of THREE YEARS from the date of execution, unless terminated earlier by a written notice of thirty (30) days by a Party seeking such termination to the other Party, hereto. However, all commitments and obligations till the date of termination will be honored by both the parties.

Neither party shall assign or transfer the privileges and obligations under this MOU without the prior written consent of the other party.

Governing Law: This MoU shall be governed by and shall be construed in accordance with the laws of India and the competent Courts in New Delhi, India shall have the exclusive interpretational, injunctive and supervisory jurisdiction over the disputes arising out of this MoU.

Dispute Resolution: Any dispute or difference arising out of or relating to or touching upon this MoU shall be amicably settled by discussion between the authorized representatives of Parties, failing which a Committee of the Senior Officers of both the parties will be constituted to settle the dispute and their findings shall be binding on both the parties.
