AICTE-CII Survey of Industry-linked Technical Institutions 2013

In 2012, the survey brought out deep insights about the industry linkages of the Indian education ecosystem and its direct and indirect benefits to both the academia and the industry. The success of the 2012 survey, has laid the path for capturing such linkages and creating an environment of learning from such success cases. In 2013, the scope of the survey includes Engineering, Management, Architecture and Pharmacy Institutes. Their industry linkages will be captured through a survey and the feedback analyzed to arrive at best institutes in every stream.

Verticals

The survey will capture industry linkages of institutes in following verticals and streams:

Institute Eligibility

- **STANDARD INSTITUTES CATEGORY**

- **For Engineering, Architecture and Pharmacy verticals:**

AICTE approved institutes, AICTE approved University departments, NITs which have been in existence for at least 10 years as on 1st August 2013

- **For management vertical:**

AICTE approved institutes, AICTE approved University departments which have been in existence for at least 5 years as on 1st August 2013

- **EMERGING INSTITUTE CATEGORY (ENGINEERING)**

AICTE approved Institutes, AICTE approved University departments and NITs which have been in existence for at least 5 years and less than 10 years as on 1st August 2013

- **EMERGING INSTITUTE CATEGORY (MANAGEMENT)**

AICTE approved Institutes, AICTE approved University departments which have been in existence for at least 3 years and less than 5 years as on 1st August 2013

Methodology

1. Institutes have to apply online using their AICTE login IDs (NITs to obtain their login IDs to the AICTE web portal by sending a mail at shalini.sharma@cii.in, and npiuw@hotmai.com)
2. Institutes can apply in any vertical - Engineering, Management, Architecture, Pharmacy
3. Institutes can apply in multiple verticals
4. Under each vertical, institutes have to apply for individual stream categories
5. Under each vertical, institutes can apply in multiple stream categories

Analysis Methodology: All the absolute data provided by the institutions will be normalized and converted to relative data to evaluate the relative distance among the institutes across different parameters. After normalization, the data will be multiplied with respective weights of each parameter and then the total objective score calculated.

Selection Process: A high level Jury constituted by AICTE and CII will select the institutes on the basis of the objective scores. An expert committee will do qualitative assessment of the shortlisted institutes. From this assessment a further shortlisting will be done and the finally selected institutes will be visited by an expert committee comprising members from industry and academia. The decision of the Jury will be final and binding for every one. Neither AICTE nor CII will be responsible for any issues of defamation or misuse of the survey results.

Validation Process: AICTE or CII can ask for any documents from the institutes to validate the information provided by them in the online survey. Apart from this, if required, AICTE and CII can conduct institute visits, faculty interviews and verify the data provided from secondary sources.

Wrong filing of Data / Forging of Data / Exaggeration of Data: Any institute found to have provided misleading / false / exaggerated information during the validation process at any stage will be disqualified from the survey for the next three years and its name will be displayed on the AICTE website as having been disqualified to participate in the AICTE-CII Survey of Industry-Linked Technical Institutes.
